SIPLAST will not be responsible for labor or any other costs to install replacement materials.

- 1. Deterioration of the Surfacing materials resulting from ordinary wear and tear by the elements;
- 2. Deterioration of the Surfacing materials resulting from manufacturing defects in said materials.

This Warranty shall be subject to the following additional terms and conditions.

## A. NOTICE OF CLAIM

Any claim hereunder shall be deemed waived unless the owner shall have given SIPLAST, INC. written notice thereof within thirty (30) days after a defect is discovered or should by reasonable diligence have been discovered.

## B. EXCLUSIONS FROM COVERAGE

- 1. Damage resulting from defective workmanship in application of the Surfacing materials;
- 2. Damage to the Surfacing materials caused by structural defects or by movement of substrate components to which the Surfacing materials are applied, including cracks or ruptures in the structural base.
- Damage resulting from any materials not supplied by Siplast that are used in conjunction with the Surfacing materials supplied by SIPLAST;
- 4. Damage to the Surfacing materials caused by lightning, windstorm, hail, earthquake, tornado, hurricane, falling objects or similarly unusual occurrence:
- Damage to the Surfacing materials caused by improper repairs or subsequent work on or through the Surfacing materials;
- Damage to the Surfacing materials caused by improper use of the material due to defects in design;
- Damage to the Surfacing materials caused by movement of metal work used in conjunction with the Surfacing materials;
- 8. Damage to the Membrane caused by abnormal, excessive or abusive traffic, snow plows or similar equipment, tire studs, tire spikes or tire chains;
- Damage to the Surfacing materials resulting from chemical attack or from other compounds demonstrated to be deleterious to the composition of the Surfacing materials.

LIMITATION OF DAMAGES; MEDIATION; JURISDICTION; CHOICE OF LAW: THIS WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER WARRANTYS OR WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, and of any other obligations or liability of Siplast, whether any claim against it is based upon negligence, breach of warranty, or any other theory. In NO event shall Siplast be liable for any CONSEQUENTIAL OR INCIDENTAL DAMAGES of any kind, including, but not limited to, interior or exterior damages and/or mold growth. The parties agree that, as a condition precedent to litigation, any controversy or claim relating to this WARRANTY shall be first submitted to mediation before a mutually acceptable mediator. In the event that mediation is unsuccessful, the parties agree that neither one will commence or prosecute any lawsuit or proceeding other than before the appropriate state or federal court in the State of New Jersey. This WARRANTY shall be governed by the laws of the State of New Jersey without regard to principles of conflicts of laws. Each party irrevocably consents to the jurisdiction and venue of the above identified courts.
